#### **Promotional Period for Introductory APR:**

The Introductory APR for balance transfers will apply to transactions posted to your account during the first six months following the opening of your account. Any existing balances on Wasatch Peaks Federal Credit Union loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

#### **Loss of Introductory APR:**

We may end your Introductory APR for balance transfers and apply the Penalty APR if you are 60 days late in making a payment.

#### **Application of Penalty APR:**

Your APR may be increased to the disclosed Penalty APR if you are 60 days late in making a payment.

#### **Effective Date:**

The information about the costs of the card described in this application is accurate as of: February 1, 2026.

1.50% of the amount of each cash advance.

Returned Payment Fee:

\$25.00 or the amount of the required minimum payment, whichever is less.

Card Replacement Fee:

\$3.00.

Document Copy Fee:

\$3.00 per document.

Rush Fee:

\$15.00 second day. \$25.00 overnight.

Statement Copy Fee:

\$3.00 per document.

Cash Advance (ATM) Fee:

\$2.00.
